 Limited Frequency of meetings, limited depth of collaborations



# The Learning Healthcare System




**Vision:** Our vision is for a healthcare system that draws on the best evidence to provide the care most appropriate to each patient, emphasizes prevention and health promotion, delivers the most value, adds to learning throughout the delivery of care, and leads to improvements in the nation's health.

Goal: By the year 2020, 90 percent of clinical decisions will be supported by accurate, timely, and up-to-date clinical information, and will reflect the best available evidence. We feel that this presents a tangible focus for progress toward our vision, that Americans ought to expect at least this level of performance, that it should be feasible with existing resources and emerging tools, and that measures can be developed to track and stimulate progress.

# Continuous Learning Healthcare System

#### **Target Setting**

define target goals and evidencebased protocols and implementation processes

#### **Research Informatics**

Analyze clinical and process outcomes to identify areas that need improvement and develop new protocols

#### **Training**

Train staff on treatment protocols, refine implementation processes, allocate necessary resources

#### **Quality Improvement**

Discuss outcomes from centers and implementation issues among peers and refine treatment implementation strategies

#### **Care Delivery**

Apply treatments in clinical centers but with common data formats to compare outcomes to targets and between centers






FIGURE 7-3 Continuous learning during performance.



## St. Jude Cure4Kids - Results

- Increased survival rates from 20% to over 50% for common types of cancer in Central America (2002-2014)
- 400 online communities expanded to include other disciplines for multi-disciplinary teamwork
- Multiplier effect impact beyond pediatric-oncology unit
- Quality Improvement Late referrals, Toxic deaths




# Evolution of a Community of Practice
